GUIDELINES FOR THE APPOINTMENT OF PRINCIPAL AND PROFESSOR IN THE PRIVATE SELF FINANCING COLLEGES INCLUDING GOVERNMENT AIDED COLLEGES AS PER UGC REGULATION 2018 and G.O.Ms.No.5, dated:11.01.2021 (Syndicate Meeting dated: 14.02.2023)

1. Call for Application

1.1. Director Recruitment: An open advertisement for calling applications for the post of Principal must be published in minimum of one Regional OR National level Dailies.

1.2. By Promotion: A Circular for calling applications for the post of Principal should be sent to all faculty members of the College.

Note: The application form (as designed by the College) and **Annexure-I** (as designed by the University) should be given to applicant and the information should be obtained as per Table 2.

2. **QUALIFICATIONS:**

2.1. **Eligibility**

- a. Ph.D. degree
- b. A minimum of 10 research publications in peer-reviewed or UGC-listed journals.
- c. A minimum of 110 Research Score (**API**) as per **Table 2** prescribed in the UGC Regulation 2018 and G.O.Ms.No.5).

2.2. **Experience:**

(a) **For Aided Colleges :**

Professor/Associate Professor with a total service/experience of at least fifteen years (15) of Teaching/Research in Universities/Colleges and other Institutions of Higher Education.

(b) **For Self-Financing Colleges :**

A minimum total experience is twelve (12) years on which ten (10) years of Teaching/ Research in Universities / Colleges and other Institutions of Higher Education and two (2) years of administrative experience like; HOD/Vice Principal/COE/Dean/ Director/Warden/NSS/ NCC is preferable.

2.3. The applicant should have already been received qualification approval either in the Post of Assistant Professor or Associate Professor from University of Madras or any other Higher Education Institution.

2.4. **Tenure:**

- i) A College Principal shall be appointed for a period of five years; extendable for another term of five years on the basis of performance assessment by a Committee appointed by the University, constituted as per these regulations.
- ii) After the completion of his/her term as Principal, the incumbent shall join back his/her parent organization with the designation as Professor and in the grade of the Professor.

3. Selection Committee for Principal:

- 3.1. The Selection Committee for the post of College Principal shall have the following composition:
- Chairperson of the Governing Body to be the Chairperson.
 - Two members of the Governing Body of the college to be nominated by the Chairperson of whom one shall be an expert in academic administration.
 - Two nominees of the Vice-Chancellor who shall be Higher Education experts in the subject/field concerned out of which at least one shall be a person not connected in any manner with the affiliating University. In case of Colleges notified/declared as minority educational institutions, one nominee of the Chairperson of the College from out of a panel of five names, preferably from minority communities, recommended by the Vice-Chancellor of the affiliating University of whom one should be a subject expert.
 - Three Higher Education experts consisting of the Principal of a College, a Professor and an accomplished educationist not below the rank of a Professor (to be nominated by the Governing Body of the college out of a panel of six experts approved by the relevant statutory body of the University concerned).
 - An academician representing SC/ST/OBC/Minority/Women/ Differently-abled categories, if any of candidates representing these categories is the applicant, to be nominated by the Vice-Chancellor, if any of the above members of the Selection Committee does not belong to that category.
 - Two subject-experts not connected with the College to be nominated by the Chairperson of the Governing Body of the college out of a panel of five names recommended by the Vice Chancellor from the list of subject experts approved by the relevant statutory body of the University concerned. In case of Colleges notified/declared as minority educational institutions, two subject experts not connected with the University nominated by the Chairperson of the College Governing Body out of the panel of five names, preferably from minority communities, recommended by the Vice-Chancellor from the list of subject experts approved by the relevant statutory body.
- 3.2. **Five members, including two experts, shall constitute the quorum.** An academician representing SC/ST/OBC/Minority/Women/ Differently-abled categories must be appointed as member of the Selection Committee which is mandatory as a member of Selection Committee.
- 3.3. All the selection procedures of the selection committee shall be completed on the day/last day of the Selection Committee meeting itself, wherein, minutes are recorded along with the scoring Proforma and recommendation made on the basis of merit with the list of selected and waitlisted candidates/Panel of names in order of merit, duly signed by all members of the Selection Committee.
- 3.4. The term of appointment of the College Principal shall be five years, with eligibility for reappointment for one more term only after an assessment by a Committee appointed by the University
- 3.5. After the completion of his/her term as Principal, the incumbent shall join back his/her parent organisation with the designation as Professor and in the grade of the Professor.
- 3.6. **Committee for Assessment of College Principal for Second Term**

The Committee for assessment to the post of College Principal for second term shall have the following composition:

- a) Nominee of the Vice-Chancellor of the affiliating University.
- b) Nominee of the Chairman, University Grants Commission.

The nominees shall be nominated from the Principals of the Colleges with excellence/College with Potential of Excellence/Autonomous College/NAAC Grade 'A' accredited colleges.

Note:

College should write to the Registrar, University of Madras requesting a panel of experts for the Selection Committee to appoint a Principal at least two months before the expiry of the term of current Principal. The Panel of Experts is valid for Six Months.

4. Vice Principal

An existing senior faculty member may be designated as Vice-Principal by the Governing Body of the College on the recommendation of the Principal, for a tenure of two years, who can be assigned specific activities, in addition to his/her existing responsibilities. During the absence of the Principal, for any reason, the Vice Principal shall exercise the powers of the Principal

5. Eligibility (A or B) : A.

- i) An eminent scholar having a Ph.D. degree in the concerned/ allied/relevant discipline, and published work of high quality, actively engaged in research with evidence of published work with a minimum of 10 research publications in the peer-reviewed or UGC-listed journals and a total Research Score of 120 as per the criteria given in **Appendix, Table 2**.
- ii) A minimum of ten years of teaching experience in University/College as Assistant Professor/Associate Professor/Professor, and / or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate.

OR

- B.** An outstanding professional, having a Ph.D. degree in the relevant/allied/applied disciplines, from any academic institutions (not included in A above) / industry, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

6. Selection Committee for Professor

- (a) The Selection Committee for the post of Professor in Colleges including Private and Constituent Colleges shall consist of the following persons:
 - i) The Chairperson of the Governing Body or his/her nominee, from amongst the members of the Governing body, who shall be the Chairperson of the Selection Committee.
 - ii) The Principal of the College.

- iii) The Head of the Department / Teacher-In charge of the concerned subject from the college not below the rank of Professor.
- iv) Two University representatives not below the rank of Professor nominated by the Vice-Chancellor, one of whom shall be the Dean of College Development Council or equivalent position in the University, and the other must be expert in the concerned subject. In case of Colleges notified/declared as minority educational institutions, two nominees, not below the rank of Professor, of the Chairperson of the College from out of a panel of five names, preferably from minority communities, recommended by the Vice-Chancellor of the affiliating university from the list of experts suggested by the relevant statutory body of the college of whom one should be a subject expert.
- v) Two subject-experts not connected with the college to be nominated by the Chairperson of the governing body of the college out of a panel of five names recommended by the Vice-Chancellor from the list of subject experts approved by the relevant statutory body of the University concerned. In case of colleges notified/declared as minority educational Institutions, two subject experts not connected with the University nominated by the Chairperson of the College Governing Body out of the panel of five names, preferably from minority communities, recommended by the Vice Chancellor from the list of subject experts approved by the relevant statutory body.
- vi) An academicians not below the rank of Professor belonging to the SC/ST/OBC/ Minority/ Women / Differently-abled categories, if any of candidates belonging to these categories is the applicant, to be nominated by the Vice-Chancellor, if any of the above members of the selection committee does not belong to that category.

(b) The quorum for the meeting shall be five, including two subject experts.

6. Selection Procedure

A Scrutiny Committee consisting of three members at the Principal/Professor level shall be constituted by the Correspondent or Chairperson of the Selection Committee. The Scrutiny Committee shall scrutinize the application and **Annexure-I** submitted by the Applicant and check the eligibility conditions and calculate the API score as per the **Table 2**

6.1 The Minutes of the Scrutiny Committee shall be presented as per **Annexure - II**

6.2 Only eligible Candidates who satisfy the minimum API SCORE as per the **Annexure - II** shall be called for Personal Interview.

- iv) Paper with impact factor between 2 and 5 - 20 Points
- v) Paper with impact factor between 5 and 10 - 25 Points
- vi) Paper with impact factor >10 - 30 Points
- (a) Two authors: 70% of total value of publication for each author.
- (b) More than two authors: 70% of total value of publication for the First/Principal/Corresponding author and 30% of total value of publication for each of the joint authors.

Joint Projects: Principal Investigator and Co-investigator would get 50% each. Note:

Paper presented if part of edited book or proceeding then it can be claimed only once.

- For joint supervision of research students, the formula shall be 70% of the total score for Supervisor and Co supervisor. Supervisor and Co-supervisor, both shall get 7 marks each.
- *For the purpose of calculating research score of the teacher, the combined research score from the categories of 5(b). Policy Document and 6. Invited lectures/Resource Person/Paper presentation shall have an upper capping of thirty percent of the total research score of the teacher concerned.
- The research score shall be from the minimum of three categories out of six categories.
